Oyster Bay Town Supervisor Joseph Saladino and the Town Board joined with local community representatives to unveil a historical marker Snouder's Corner Drug Store, the oldest

continuously operated business in the

hamlet of Oyster Bay. Officials also cel-

ebrated the grand opening of new French restaurant L'Etoile at the location, and thanked property owners Tim Lee and Claudia Taglich, as well as businessowners including the Milana family who operate L'Etoile.

SnoudersCorner Drug Store, the oldest operating business in Oyster Bay, was home to the first and only telephone in the community in the 1880s. When Theodore Roosevelt became Governor of New York, and later the President, the press corps would gather at Snouders so they could transmit news from Oyster

Bay. In 1889 Mr. Snouder installed a soda fountain, which became a center of social life for several generations of young people, who enjoyed soda and refreshments at the establishment for almost a century, into the 1970s.

"Today, we honor the past, celebrate the present, and look forward to a prosperous future in our hamlet thanks to the commitment of those who have helped bolster our

### Oyster Bay \$30M Chinese **Scammers Face Prison**

For more than a decade, Sherry Xue Li and Lianbo "Mike" Wang of Oyster Bay promoted ventures in New York under the name "China City of America." Now both are convicted federal criminal felons facing years in prison for running a \$30 million-plus 'Ponzi scheme.'

Li and Wang told prospective backers—many of them in China—that their money would not only help build a private educational campus, but would also

obtain American "green cards" through an EB-5 program; access to prominent politicians; and investment returns (including an eventual IPO).

In 2022, federal prosecutors in the Eastern District of New York unsealed a complaint charging Li and Wang with: (1) wire-fraud conspiracy, (2) money-laundering conspiracy, and (3) conspiracy to defraud the United States by obstructing the Federal Election Commission's enforcement of campaignfinance law.

Agents alleged the pair raised tens of millions of dollars on false promises and then used investor funds-rather than their own—to buy their way into

make unlawful campaign contributions according to the government. in their own names. Both were arrested that day.

The complaint described an intricate, multi-layered scheme: roughly \$16.5 million from EB-5 seekers promised permanent residency, plus additional millions from stock purchasers who were told that the company would go public.

Prosecutors said the "green cards" never materialized, the IPO never happened, and the TEC campus never got beyond showy but insubstantial steps all the while, large sums were diverted to shell companies, personal spending, and political donations which masked foreign sources.

A distinctive feature of the case was

the political-access angle. Prosecutors said Li and Wang collected money from foreign nationals and then unlawfully contributed those funds under their own names to various U.S. political commit-

One such contribution led to the couple being invited to attend a June 2017 fundraiser where Li posed for photos with then-President Donald Trump and the First Lady. Those images were later used in promotional materials to impress prospective investors.

The government's filings and subsequent coverage emphasized that the "straw" donations were financed by foreign-sourced funds mostly from China - and then routed through the defendants.



high-dollar political fundraisers and to to market credibility to future investors,

Public records show the original "China City of America" proposal never secured local approvals, and the successor TEC concept never matured into an accredited, operating campus. The land became a "stage set" for investor tours and renderings rather than the revenuegenerating institution investors were promised.

Lianbo Mike Wang is now serving a five-year federal sentence imposed in 2024 after his guilty plea.

Sherry Xue Li pleaded guilty on July 30th, where she agreed to forfeit \$31.5 million and three properties and faces up to 20 years in prison at a December 2025 sentencing. She has been detained since her 2022 arrest.



#### WALKING ON THE ROAD

Dear Editor;

I've had a couple of friends hit in recent years One was out walking and was badly mangled but did live with several surgeries and therapy. Another friend was hit and killed.

You can't take for granted that drivers are paying attention. So many drivers today are talking on their cell phones, texting, jiving to music or looking at everything other the road. You can't depend on drivers to assure

you of your safety. We should all drive acutely aware of the road and our surroundings but drivers make mistakes. A jogger doesn't want to be in the path of someone who is distracted.

Today, I see kids in our neighborhood riding on mopeds with earplugs in listening to music. They are laughing and having a great time. Then there are the golf carts with kids hanging onto the back of them or ATV vehicles that are illegal on most public roads. An ATV going down the road at dusk with no headlights is a scary sight. Are they able to see you if you are on the road walking? Probably not.

The best we can do is our best. If you are going to walk on the road, keep your attention in all directions. Try to move a couple feet off the road until cars pass. Give them plenty of room. This is not the place to "stand your ground." Don't listen to music. You need to hear whatever is coming.

We all need exercise but not at the risk of death. I'm grateful that I can still walk and jog some. I constantly try to stay aware. As drivers, our job is to slow down a little and drive as cautiously as possible.

### Op-Ed: Protecting Our Kids & Keeping Nassau County Safe

As County Executive, I am proud to announce that Nassau County has reached unprecedented levels of safety during my time in office. Despite having a higher population than ten U.S. states, our crime numbers have continued to

decline every year. After falling by 9% in 2024, major crimes are now down by over 13% in Nassau County year-to-date in 2025. This is a massive accomplishment for our Nassau County Police Department, and it's a major reason why we continue to be regarded as the safest county in America.

But despite our accomplishments, we know that we can never rest on our laurels.

Every day, we strive to find new ways to bring security and peace of mind to our residents. One of my top priorities is protecting our children from criminals who threaten their security at school. With a new academic year underway, many parents might be feeling anxious about shootings and other devastating events that have repeatedly happened

across our country. However, I am taking every possible step to ensure that those tragedies do not happen in Nassau County.

Last month, I announced that the Nassau County Police Department was

creating and deploying a new Strategic Response Team to specifically safeguard our schools and mitigate any threats to students, teachers, and faculty. The team is made up of dozens of dedicated police officers who work closely with school officials to identify and prevent potential threats. I'm proud to say that the team's deployment was a complete success for this year's back-to-school transition, and it will be a crit-

ical tool moving forward for all our educational institutions in Nassau County.

Part of keeping our children safe is also ensuring that the streets they live on are free from crime. The Nassau County Police Department is doing an excellent job of collaborating with local, state, and federal partners to achieve this goal. Just last month, we coordinated a tactical

takedown of gang members with the assistance of ICE officials. We arrested dozens of dangerous criminals in less than a week, with many of them being known members of gangs like MS-13, the 18th Street Gang, and the Trinitarios.

This monumental achievement was the largest gang takedown in Nassau County history, and it helped remove illegal criminals who had no business being here in the first place. Nassau County is NOT a sanctuary county, and we will not tolerate criminality from illegal migrants who threaten our neighborhoods

Tackling public safety issues is critically important to me, which is why I have made so many investments in our local police. While other counties and leaders are reducing their focus on public safety and seeing an increase in crime, I have authorized hiring over 600 police and correctional officers during my time in office. I plan to expand our law enforcement hires even further in the years to come to continue giving our residents the security they deserve.

Our officers will be the best in the nation thanks to a brand-new police training village that we opened this summer. This critical resource will ensure that the brave men and women who protect us receive the best available training

### **Op-Ed: Let AI Re-draw District Lines**

In Texas, we see Democratic state legislators flying the coop as Republicans try to manipulate the redistricting process to maximize Republican districts.

Meanwhile, in New York, Republicans are complaining that the Democrat-controlled legislature is trying to maximize redistricting to their advantage.

It's the same old story where both sides of the aisle play games on redistricting to benefit themselves. It's why reformers have been pushing for decades to get the process out of the hands of self-interested elected officials whose only goal is to protect their incumbency.

When I was county executive, I passed a landmark bill to take the role of redrawing the

lines away from the elected officials and place it instead with an Independent panel. It was passed with great fanfare with the governor coming to Suffolk County to lend support as I signed the legislation.

But, lo and behold, several years later, when it was about to kick in, the Democrat-controlled legislature abolished the reform and went back to the old system of having the legislature control the process. This was done, of course, because, at the time, the Democrats were in control

It's wrong for either party to manipulate this process.

It's true that the Republicans in Texas are throwing a new fly into the ointment by opting to implement the 10-year redistricting process — which usually coincides with the disclosure of the new census — five years earlier than normal. They're doing this to try to get as many as five new seats for the GOP prior to the 2026 midterms.

Now, Democratic Governors from California and New York - and elsewhere - are warning that they will do the same to maximize seats for Democrats before the next census.

But the Democrats don't have clean hands here, either.

We need independence. But some complain that even when you appoint good government groups and

retired judges to do it, politics will still come into play.

Ironically, it was in New York, where a voter-approved 2014 referendum to establish such independence was sought to be circumvented by the Democrats.

When New York's independent panel established a more independent drawing of the lines, the Democrats immediately sought to ignore it and drew their own partisan districts. The GOP brought suit upholding the independent lines which led to Republicans picking up four crucial seats in New York in 2022, handing the House of Representatives back to the GOP.

The Democratic majority even had the audacity to revamp the state's highest court, the Court of Appeals, by forcing out the moderate Democratic Chief Justice, and putting in place a far leftist jurist who supports their gerrymandering.

Unfortunately, even well-intentioned attempts of reform can often fail to produce the desired results. Take California, which in 2008 passed a Referendum supported by then-Governor Arnold Schwarzenegger - to create an Independent Commission to draw the lines

If its goal was to create fair districts that would create a better bipartisan balance, it was a failure.

At the time of the referendum's passage, California had 34 Democrats and 19 Republicans from the state's congressional caucus. By 2025, there were 9 Republican seats left throughout the state.

While much of this can be attributed to changing demographics and political issues of the day, some of it might be attributable to the biases of even those appointees who are claimed to be non-partisan.

So, here is a solution. Why not have the lines redrawn by using Artificial Intelligence?

Just log in that we want the fairest redistricting possible to create as bal-

anced a district as possible from the perspective of demographics and political party registration. That would take the politics out of the system and make our races more competitive. And best of all, it would ultimately make our elected officials more reactive to the center rather than the extremes on both sides of the political spectrum.

Of course, the outcome of AI is only as good as what is inputted. Care must be given to ensure that a balanced group of nonpartisan technocrats prepare the algorithms, as opposed to party hacks. To maximize the potential for delivering the fairest lines possible, take a grouping of five potential maps spit out by the computer and throw them into a lottery barrel and pick a winning plan randomly, as it was once tried in North Carolina before partisan lawsuits marred the process.

There's no foolproof solution, but AI may present the best of all the options available.

Jimmy was one of the founders of the Mill River Rod and Gun Club. Pat and served to all the kids and thier families.






