

City of Glen Cove Achieves First Surplus Since 2017 and Earns No Fiscal Stress" Rating from State Comptroller

The City of Glen Cove is proud to announce two significant milestones that underscore the city's continued financial

turnaround. For the year ending December 31, 2024, Glen Cove achieved its first accumulated surplus since 2017, closing the year with an \$87,556 positive balance. In addition, the New York Comptroller's State Office, under Comptroller Thomas DiNapoli, has once again designated Glen

These results mark a dramatic improvement from years of deficit, with Glen Cove carrying negative balances from 2018 through 2023. Under the leadership of Mayor Pamela D. Panzenbeck, and thanks to the dedication of City Comptroller Michael Piccirillo and his team, as well as the collaboration of all city department heads, Glen Cove has steadily strengthened its finances—moving from a deficit of more than \$5 million in 2020 to today's accumulated surplus.

"Glen Cove's finances are stronger

than they have been in many years," said Mayor Panzenbeck. "This accom-


plishment is a direct result of the teamwork, responsibility, and fiscal discipline practiced by our city's leadership. City Comptroller Michael Piccirillo added, "Turning a \$5 million deficit into a surplus took persistence, discipline, and teamwork. I am proud of my staff and grateful for the support of Mayor

The last time Glen Cove held an accumulated surplus was in 2017. After seven





Suffolk GOP Chair Blasts Newsday for Charlie Kirk Smear: **Paper Retracts and Apologizes**

In a quick "aboutface" the daily Long Island newspaper Newsday pulled down an offensive cartoon against the assassinated conservative activist Charlie Kirk, and publicly apologized.

The newspaper's actions were prompted by a public demand for retraction from Suffolk Republican Chairman Jesse Garcia.

"Newsday - the only daily paper on Long Island - has crossed a line," stated Garcia. "By publishing a vile cartoon about the political assassination of Charlie Kirk, the paper has mocked tragedy, stoked division, and poured

gasoline on the flames of political violence."

"This isn't journalism. It's a reckless, partisan attack that blames the victim, silences free speech, and shames everything this country should stand for," added Garcia.

The offending cartoon was drawn by Chip Bok of Creators.com, and mocked the conservative Charlie Kirk, implying that he was "proven wrong" with a fatal shot

to his neck. The cartoon portrayed a "blood spatter" behind an empty chair where Kirk was killed.

Garcia demanded that the cartoon be pulled, the "artist" be fired, and an apology made to the Kirk family, Newsday's readers, and to every American who believes in freedom of speech.


Within hours of Garcia's letter and press release, Newsday pulled the cartoon, and issued a public apology.

"Newsday published a syndicated editorial cartoon referring to the assassination of Charlie Kirk that was insensitive and offensive," wrtote Newsday's Publisher. "We deeply regret this mistake and sincerely apologize to the family of Charlie Kirk and to all."

'We made an error in judgment," added Newsday. "The cartoon has been removed from our digital platforms."

Garcia accepted Newsday's apology, exclaiming "Decency prevails!".

"Today, a little more than 19 hours after the statement from our Suffolk GOP condemning this disgraceful political cartoon, Newsday has publicly acknowledged its mistake, apologized to the Kirk family, its readers, and the broader public, and removed the cartoon

from its platforms." stated Garcia.

'On behalf of the Suffolk County Brookhaven Republican Committees, I accept this apology.'

"We recognize that owning up to such an egregious error is not easy, and we hope this moment serves as a reminder to every newsroom in America that words and images matter," added

Oyster Bay Planting "Rain Gardens"

Oyster Bay Councilwoman Vicki Walsh and Town Clerk Rich LaMarca are inviting volunteers to help plant and maintain the Town of Oyster Bay's "Rain Gardens," to prevent runoff and build healthy soil and native plants in our parks and waterfronts.

"A rain garden is a collection of native plants placed in a small depression to temporarily hold rain water runoff from roofs, driveways, patios, or lawns," explained Vicki Walsh. "They have numerous environmental benefits, such as filtering pollutants, reducing flooding, and providing food and habitats to wildlife.'

During the Rain Garden Work Party scheduled for Saturday, October 11th, volunteers are needed to assist with weeding, raking, pruning, mulching, and transplanting existing rain gardens, while learning about the environmental benefits these structures offer.

The Rain Garden Work Party will be held from 9am to 12pm at the Western Waterfront in Oyster Bay.

"This is a critical element of the Town's pollution prevention strategy," added Walsh. "And they must be maintained regularly to ensure healthy soil, healthy plants, and a healthy community, which is why we're seeking volunteers to assist with our existing rain gardens at the Western Waterfront in Oyster Bay."

The Rain Garden Work Party will be held on Saturday, October 11th from 9am to 12pm at the Western Waterfront, located at 1 West End Ave, Oyster Bay (Larrabee entrance of TR Park, to the left).

This event is being held in partnership with Friends of the Bay and The Nassau County Soil and Water Conservation District.

Volunteers should bring gloves, and community service hours will be offered to participants.

As an added bonus, participants can learn how to apply for the new Long Island Garden Rewards program, which offers up to a \$500 reimbursement for installing rain gardens and incorporating native plants on your property.

"From helping to cap ture runoff so it does not pollute our waterways to preventing the breeding of mosquitoes, rain gardens have a tremendously positive impact on our environment and water quality," added Town Clerk Rich LaMarca. "We hope to see you on October 11th at the

Western Waterfront to help maintain these gardens."

Baby Osprey Rescued in Oyster Bay

A baby Osprey was rescued in Oyster Bay by a community effort that saved the young bird, nurtured it back to health, and returned it back to it's family nest in Oyster Bay.

The baby Osprey was rescued in July, and it was one of three chicks being raised by the Osprey parents in Oyster Bay.

The parents have nested on the PSEG Long Island-sponsored nesting platform just off the beach near Theodore Roosevelt Park in downtown Oyster Bav.

PSEG maintains a 24/7 webcam on the Osprey nest, which is a major indicator of the health and well-being of these birds – specifically this one.

When scientists noted that the baby Osprey looked listless and malnourished, a team from PSEG, the Town of Oyster Bay, and the Sweetbriar Nature Center sprang into action and quickly rescued the baby bird.

Sweetbriar took-in and cared-for of the baby osprey, where it spent the next five weeks, as it was fed and nurtured back to full health.

"It truly takes a village," a representative of Sweetbriar Nature Center said, describing the team effort to save the young Osprey, adding that "the young osprey may not have been getting an ample amount of food."

After the bird was able to fly on its own, the PSEG group released the osprey, back in Oyster Bay, which has



ample supplies of food and resources.

"We work closely with wildlife conservation partners to protect osprey from high-voltage equipment," added David Lyon, the interim COO and president of PSEG. "Good environmental stewardship is part of being strongly involved in the community, and because it also improves reliability for cus-

JAMES COMEY DESERVES JAIL

FREE PAPER SHREDDING SERVICES AVAILABLE DURING HOMEOWNERS CLEANUP

To the Editor

Town of Oyster Bay announce sthe Town's S.T.O.P. (Stop Throwing Out Pollutants) and Homeowners Cleanup programs will hold their final drop-off days this October. Residents can drop off materials at the Old Bethpage Solid Waste Disposal Complex, located at 101 Bethpage-Sweet Hollow Road in Old Bethpage.

Homeowners Cleanup Day -Saturday, October 4th from 8:30am -4pm: residents can bring non-hazardous waste only, including: air conditioners; all e-waste; campers; boats and boat trailers (proof of ownership required - oil, gas, other fluids and batteries removed); clean, broken concrete; large metal items; propane tanks and propane torches; tires; and yard

The fall season often brings with it the cleaning of our yards and winter preparation, and many residents may have significant amounts of non-hazardous debris to dispose. Residents can bring items such as used tires, fence posts, clean broken concrete or yard waste to our Homeowners Cleanup, as well as unwanted documents to be disposed in a safe and secure manner through our free shredding services.

Free Paper Shredding Services -Saturday, October 4th from 8:30am -4pm: provides residents an opportunity to destroy unwanted documents in a safe and secure manner. Residents only, no businesses, can bring up to four bankers' boxes of paper to the shredding program. Residents can bring up to four bankers' boxes of paper for the Town's paper shredding program, held during Homeowners Cleanup Day

S.T.O.P. program - Saturday, October 18th from 9am - 4pm: collects various hazardous materials, including: asbestos material (double bagged); automobile batteries; automobile tires

(with or without rims); brake and transmission fluids; drain and oven cleaners; fire extinguishers; fares; fluorescent bulbs; gasoline; pesticides and insecticides; oil-based and latex paint; outdoor gas grill propane tanks; photo chemicals; rechargeable and button batteries; small aerosol cans; smoke detectors; solvents; spot removers; thermostats; waste motor oil and antifreeze; and wood preservatives.

Improperly disposing of products such as waste oil, oven cleaner or paint thinner could contaminate your water supply. Anything poured on the ground or put into cesspools, storm drains, or recharge systems can work its way down to the aquifer or our waterways.

The Town's S.T.O.P. Homeowners programs are open to residents within the Town's Solid Waste Disposal District. Proof of residency is required. For more information, including a full list of what is accepted at these programs, visit www.oysterbaytown.com/cleanup or call (516) 677-5848.

Op-Ed: Alternative Electors Case Yet Another Example of "Lawfare"

The Courts recently dismissed all charges against the "fake" electors for Michigan from the 2020 election. The dismissal was barely reported by the media.

But as I wrote over a year ago, the

very bringing of that case was a travesty.

Even now, as illustrated in multiple headlines, the mainstream media continues to spread the false narrative that these were "fake" electors.

In the history of our country, those objecting to the electoral process were always properly categorized as "alternative" electors. It's a system embedded in the

U.S. Constitution and federal law.

Where state officials believe that there was chicanery in the electoral process, they have the legal authority to send to the electoral college a slate of electors who will refuse to certify the process, and, instead, make the claim that fraud was involved in the ultimate outcome.

This is not something that was unique o 2020.

In 1876, various states objected to the process that gave Samuel Tilden the victory in the electoral count. The supporters of Rutherford B. Hayes sent their own slate of alternative electors to be prepared

to issue a vote for Hayes once the congressional and judicial process of sorting out the allegations was complete.

The matter was eventually settled in the Compromise of 1876, which gave Hayes the presidency.

In 1960, Democratic presidential candidate John Kennedy objected to the tally in Hawaii, which was originally won by Richard Nixon.

His alternative slate was established. They were not called "fake" electors. Upon the recount, the state was given to Kennedy.

Never in our history before 2020 have these alternative electors been labeled "fake" electors and charged with a crime.

It was absolutely disgusting that

Biden's Justice Department and Democratic prosecutors teamed up with a willing liberal media to target those exercising their constitutional prerogative of creating alternative electors.

They unjustifiably labeled the alternative electors as being part of an insurrection, thereby leading to the prosecution of everyday people who simply wanted their voices heard.

We're not talking about rioters at the Capitol on January 6th. We're talking about average citizens and campaign lawyers ready to appear at the electoral college to cast the vote for their candidate — if and only if the courts were to determine that the original count or process was invalid. (Had they not established the alternative slate of electors, they would not have the ability at the electoral college to vote for their candidate if a court indeed ruled that he had won the election in that state.)

As noted in a recent BBC article on the court's dismissal: "District Court Judge Kristen D Simmons dismissed forgery, conspiracy and other charges against the group and ruled they had legally exercised their constitutional rights."

Those people - exercising their consti-

tutional rights - were prosecuted and put through hell.

Many of them were harmed economically, lost their jobs or were shunned from society. But now, without a whimper, a court has agreed that there was no merit to these prosecutions.

Just as there was no merit in bringing charges against Trump's lawyers, from Rudy Giuliani to John Eastman, for giving their advice that President Trump could use the alternative elector process, just as Presidents Kennedy and Hayes did previously.

Now that these electors have won their case, we hearken back to Ray Donovan, a former Reagan Labor Secretary, who was exonerated in a case brought against him. He asked after his trial: "Which office do I go to to get my reputation back?"

Op-Ed: Shutdowns Should Never Be Used for Partisan Leverage

Democrats Suozzi and Gillen previously said no, I said no in 2023, but today's Democrats are saying yes to force through pandemic-era Obamacare subsidies.

In 2018, during the longest government shutdown in our nation's history, my colleague Rep. Tom Suozzi (D-Glen Cove) said plainly: "We shouldn't be

holding all these people's lives hostage because [the President is] trying to negotiate a deal for an issue he wants."

In October 2023, Rep. Laura Gillen (D-Rockville Centre) echoed that view, warning shutdowns "put millions at risk and [waste] more time from Congress actually doing the work of the American people."

They were right to make those statements. Shutting down government operations as a bargaining tactic is reckless, it hurts ordinary Americans, and it undermines national security.

That's why, in 2023 and 2024, despite strong disagreements with President Biden's open-border policies, I refused to use a shutdown to fight that battle.

Along with other responsible Republicans—including fellow Long Islanders Andrew Garbarino (R-Bayport) and Anthony D'Esposito (R-Island Park)—I voted to continue funding the government. We knew who would get hurt if we didn't: our troops, our veterans, and the 31,000 federal employees on Long Island who keep critical services running.

Our fight over border policy belonged in the legislative and electoral arenas—not on the backs of families and federal workers.

Now, in 2025, DC Democrats are taking the opposite approach.

Just last week, Democrats— House including Suozzi and Gillen, who themselves once warned against shutdowns-voted to shut down the government outright by rejecting a clean 52-day funding bill with no partisan riders that simply extended existing Biden-era spending.

Why? To use a shutdown as leverage to extend pandemic-era Obamacare subsidies,

by their own admission.

The consequences would be felt here at home. At Brookhaven National Lab, 3,000 scientists and engineers could see their work disrupted.

Newsday has reported that shutdowns risk leaving troops, air traffic controllers, and tens of thousands of federal workers on Long Island without pay—creating financial hardship for families and delays in air travel.

Services at the Northport VA Medical Center - relied on by thousands of veterans - could be disrupted.

For seniors, while Social Security checks would continue, a shutdown

would delay local services, threaten nutrition programs, and weaken oversight of nursing homes.

The double standard is striking. When it was President Trump's border wall, Democrats argued shutdowns were reckless.

When it was President Biden's open border, Republicans still chose to fund the government. But now, with

Democrats' own priorities on the line, they are willing to grind government to a halt.

The American people deserve better. Shutdowns should never be a partisan tool.




