Back-To-School Backpack Giveaway





Preservation LI holds "Country House Benefit" in Locust Valley

Preservation Long Island held its 2025 Annual Country House Benefit at the meticulously restored Locust Valley home of designer Alfredo Paredes.

The event was a celebration of Long Island's incredible architectural history, to supports its mission to celebrate and preserve Long Island's diverse cultural and architectural heritage.

"We were thrilled to celebrate Alfredo Paredes and Brad Goldfarb's incredible restoration of their 1928 Harrie Lindeberg house in Locust Valley," stated Jackie Powers, Executive Director of Preservation Long Island. "The sold-out evening raised critical funds to support PLI's growing programs."

The Locust Valley home—now known as "Cocuyo," meaning "firefly" in Spanish—was thoughtfully restored by Paredes to pay homage to the home's original architecture.

Cocuyo was a natural choice of venue for PLI's Annual Country House Benefit, as the architect Lindeberg, was a pioneer of the American Country House movement, and designed the home for 20th-century portrait artist F. Edwin Church.

Paredes carefully preserved many of the home's original details—including frescoes of birds painted by Church on the loggia walls, original ceramic tile floors, and cast-iron dragon lanterns. With utmost respect for the home's heritage, the original architectural design has been preserved while infusing it with personalized design choices.

The hosts opened their home to party guests, who enjoyed cocktails and hors d'oeuvres while taking in the spectacular interiors, beautiful gardens, and exquisite exterior details. PLI's curatorial and historic preservation staff were stationed throughout the property to share information about the house's history and architectural features.

In the living room of the home, an original Art Deco portrait by Church, named "Lady in Charlotte's Dress," as well as other Church paintings, were on

loan for the evening.

PLI Board President Michelle Elliott Gokey welcomed guests and shared highlights of Preservation Long Island's work, before introducing the organization's newly appointed Executive Director, Jackie Powers.

The partygoers left with PLI's signature tote bag, filled with gifts from benefit sponsor Farrow & Ball, and each guest also received a signed copy of "Alfredo Paredes at Home," Alfredo's recently released debut book.

Centre Island Mayor Lawrence Schmidlapp - RIP

Lawrence Cooper Schmidlapp ("Larry"), 80, passed away peacefully, surrounded by his family, at his long-time home on Centre Island on

Saturday, August 16, 2025.

Born on February 5, 1945, in Brigham City, Utah, to Carl Jacob Schmidlapp II and Barbara (McKissock) Schmidlapp, Larry grew up with a deep love of family, community, and the outdoors. He attended The Green Vale School, Millbrook School and Kenyon College.

Larry proudly served his country in

Army Intelligence during the Vietnam War. After returning home, Larry began a successful 38-year career in municipal bond sales, spending the majority of his career at Merrill Lynch and JPMorgan Chase. Larry dedicated much of his life to Oyster Bay and the North Shore community. He credited his education at Millbrook School for instilling in him the value of community - a principle he carried throughout his life.

Larry was a founding member of the Centre Island Land Trust and Friends of the Bay. He also served as a trustee of the North Shore Land Alliance, The Green Vale School, Oyster Bay Boys & Girls Club, The Waterfront Center and Seawanhaka Corinthian Yacht Club. He was the past president of the Beaver Dam Winter Sports Club and most recently held the position of Commander of the Locust Valley American Legion.

Having moved to Centre Island with his family in 1948, Larry served the Village for 20 years, first as Trustee, then as Mayor for 15 years, following in the

footsteps of his father who served as Mayor in the early 1980s. As Mayor, Larry was "community (and action) above self" - residents may have seen

him clearing blocked roadways after a storm with his chainsaw or plowing driveways in the winter with his Suburban.

Larry had a lifelong love of the water, spending countless hours with family and friends aboard his boats, Shadow and Gatsby. He was happiest on the water - Larry's most cherished time ofthe year was the week-long family

ly cruise up the Long Island Sound, a tradition the family kept well beyond the "kids" being kids. His favorite place in the world was on his deck looking out over Oyster Bay Harbor, which is where he spent his final days.

Known for his humor, charisma, and easy-going nature, Larry was deeply loved by everyone he met. His family and friends will miss him deeply but find inspiration and remembrance of Larry all around this community.

Larry is survived by his wife of 40 years, Carol; his children Charlotte E. Schmidlapp (Kelly), Lawrence M. Schmidlapp (Caroline), and Carl J. Schmidlapp IV; his grandchildren Ivy E. Schmidlapp, and Archer L. Robinson; and his siblings Carl J. Schmidlapp III, Barbara S. Dembergh, and J. Alison Douglas. Larry was preceded in death by his brother, Allan C. Schmidlapp.

Disgraced Fraudster George Santos Reports to Prison

Disgraced Ex-Congressman George Santos (NY-3) reported to federal prison to begin serving his 7-year prison sentence for criminal fraud, theft and filing false documents.

The truth about Santos' frauds and crimes was broken before the November 2022 elections by investigative reporters from the North Shore Leader - and later picked-up by the New York Times and other national media after Santos became the surprise winner in the election to Congress.

"I went from standing at the pinnacle of power and prestige, attending galas, navigating multimillion-dollar fundraisers in glittering Manhattan apartments and Long Island mansions, to the rock bottom of federal confinement," cried Santos from prison.

Santos was indicted in May, 2023, on 23 felony counts by the US Attorney in the Eastern District of New York, and plead "guilty" to two counts - but admitted to committing the other 21 counts in an elocution at his plea agreement last August.

Santos checked into prison and began serving his sentence at the medium-security FCI Fairton prison in Fairfield Township, New Jersey.

Santos was seen entering the prison grounds crying, and being greeted and hugged by five supporters carrying signs claiming Santos was innocent.

Santos has been described as "a one man international crime spree."

Santos was involved in a 2018 credit card fraud ring in Orlando, Florida; a 2020 "ponzi-scheme" involving a looted \$20 million investment fund called "Harbor City Capital" out of Melbourne, Florida; and a 2016 charity scam where Santos used the plight of a sick dog named "Sapphire" belonging to US Navy veteran Richard Osthoff to steal the \$3500 raised to save Sapphire's life.

Thanks to Santos' cruelty and greed, the dog died, leaving Osthoff alone, broken and suicidal.

"George Santos is a sociopathic, cruel man, who has preyed upon decent people - and the weak and wounded - for decades," stated Grant Lally, the Publisher of the North Shore Leader. "I am glad we had the courage to expose his evil and corruption, and that he is now behind bars, where he can't hurt innocent victims anymore."

THE MADNESS OF MAMDANI - AND LONG ISLAND'S OPPORTUNITY

New York City is being hit with a perfect political storm that is about to sweep-in Zohran Mamdani - a 33-year old radical socialist - as Mayor of America's greatest city.

The prospects for NYC are horrific:

For law-abiding citizens, he offers a demoralizing blow to the NYC Police; and a green light to all sorts of criminals, muggers, scammers and thieves that it will be "open season" in NYC.

For parents, Mamdani promises an attack on educational hope: from his hostility to charter schools and what he calls the "racist" competitive NYC public high schools.

Regional hubs - like Mitchell Field; downtown Hicksville; the Melville commercial corridor; the Ronkonkoma renaissance; and the Stony Brook research triangle - are all ripe for an infusion of new head-quarters and top-paying jobs are businesses flee from a nightmare NYC.

Let us take maximum advantage that NYC's looming tragedy can afford us here on Long Island.

Major Infrastructure Upgrades at Northport VA Medical Center

The Northport VAMC will receive a portion of an additional \$800 million in federal funding for VA infrastructure upgrades nationwide. The funds come as a result of cost-saving reforms within

the Veterans Health Administration (VHA) and will support a series of key improvements to enhance care and safety for Long Island Veterans.

These investments are a direct result of recent reforms to make the VA more efficient and Long Island Veterans are seeing the benefits. From critical facility

upgrades to expanded clinical space and improved safety systems, this funding will help the Northport VA deliver on its promise to those who served. Our Veterans on Long Island deserve first-class care in a 21st century facility. This is a win for Long Island's Veterans and I'll continue fighting for them in Washington.



The Department of Veterans Affairs will realign an additional \$800 million this fiscal year as part of the Veterans Health Administration's Non-Recurring Maintenance (NRM) program, which makes infrastructure improvements to health care facilities to ensure safe and effective patient care.

The additional funds will come from savings gleaned from various Veterans Health Administration (VHA) reform efforts. The additions will bring total NRM program spending for fiscal year 2025 to \$2.8 billion — a nearly \$500 million increase from fiscal year 2024. The funding will support a wide range of projects at the Northport VAMC, including:

- Upgrade Emergency Generators, Phase I – Electrical Infrastructure Improvements (Construction)
- Renovate for Nuclear Med Tomography – Medical Equipment Site Preparation (Construction)

Improve Bldg. 200 Pipe Basement
 Utility System Upgrades (Design)

• Repair PV Solar Carport System – Site and other Structural Improvements (Construction)

Map Wastewater and Stormwater
 Collection System – Utility
 System Upgrades (Design)

• Renovate Dialysis – Renovation of Clinical/Support Space (Construction)

• Complete Sprinklers in Buildings 63, 64, 65 – Life Safety Systems, Sprinkler/Fire Alarm (Design)

• Roofs and Facades, Building 12 – Site and other Structural Improvements (Construction)

• EHRM Infrastructure Upgrades – Electronic health record modernization (Design)

• Replace Primary Electrical Distribution, Phase I – Electrical Infrastructure Improvements (Construction)

• Replace Roofs and Facades, Phase I of Buildings 61/62 – Site and other Structural Improvements (Construction)

• Renovate Sterile Processing Department 200 – Renovation of Clinical/Support Space (Construction)

• Replace Boilers – Central Utility Plant - Boiler & Chiller Systems (Construction)

Since January, I introduced five pieces of legislation aimed at improving care for our nation's Veterans, including the bipartisan PFC Joseph P. Dwyer Peer Support Program Act with Congressman Jimmy Panetta (D-CA), the bipartisan Vietnam Veterans Liver Fluke Cancer Study Act with Congressman Pat Ryan (D-NY), the Supporting Veteran Families in Need Act with Congressman Ed Case (D-HI), and the Veterans Foreign Medical Coverage Equality and Modernization Act, and the Troops Before Politicians Act, which mandates pay suspension for Members of Congress when pay is suspended for Servicemembers.



Music was provided by John Schwartzberg on the piano and the Nick Massimo Quintet jazz group.



CASSIDY, William Joseph, a native New Yorker who spent the last few years of his life residing in Vernon, CT, passed away on the evening of Sunday, August 17, 2025 at the age of 84. William, known to his family and friends as Bill, was a devoted husband, father, and PopPop. With a jovial spirit, a huge warm heart, and charismatic charm, Bill was the anchor of the family, filling his home, and our hearts, with love and laughter.

Born in Brooklyn, NY, on August 3, 1941, Bill lived an adventurous life. A natural storyteller with the "gift of the gab" he loved to share his tales with family and friends, but saved his best stories for his three girls. Ripe with tales of 1940's NYC, Bill would share his many escapades from what it was like being on rations during the war, how his Uncle Jim would take him to see his beloved Brooklyn Dodgers (and help him get his ball signed), swimming in the Hudson river, chasing frogs, watching the St. Patrick's day Parade from the stock room of Saks Fifth Avenue with his father, to the sheer horror and embarrassment of walking with his grandmother as a child when she told off Joey Gallo on the streets of Brooklyn.

His father, William Patrick Cassidy, passed away when Bill was sixteen years old. It was then that he and his mother. Mary Cassidy (nee Cornely) moved to Bellerose, NY with their cousins. Having been born with retinitis pigmentosa, a severe eyesight impairment, Bill attended school in the NYC Vision Conservation program which saw him through elementary school at PS 95 and then on to William Cullen Bryant High School in Astoria, NY where he developed a love for photography and took photos for the school newspaper. After graduating high school, Bill went on to work at Saks Fifth Avenue like his father and grandfather before him. A savvy salesman with an eye for design, Bill rose up to work as a buyer for the jewelry department. Some of his favorite stories come from his time at Saks, from charming Edie Adams (and her dog) and curating selections for Barbara Streisand, to assisting his fellow colleagues during the great NYC blackout of 1977.

It was during his time at Saks that he met his wife, Barbara, a nursing school student who was on rotation at Creedmore Hospital, while he worked there curating a library for patients. The two would eventually get married in Bayonne, NJ and make the papers for having every member of their wedding party get married afterwards, including the priest! The young couple settled down in Yonkers, NY and started a family of their own, welcoming their first child, Kathleen, in 1971, and their second, Maureen in 1975. In the later seventies, they moved to Rego Park, NY where they lived with Bill's mother and where Bill would move on from Saks to work for Kosta Boda, a Swedish Glass company.

His work for Kosta Boda would take him all over the world as he would meet with artisans to secure unique and beautiful glassworks for Kosta Boda to carry. In the fall of 1980, after welcoming his third child, Kimberley, he would lay his beloved mother Mary to rest. One year later, the family would find themselves moving to the suburbs of NYC to Lindenhurst, NY, a town his cousin Patricia Rooney helped him vet. Bill loved tending his vegetable garden and enjoying the pool in his own backyard. A dedicated father, he always devoted his one day off a week, in addition to vacation, to his family. From the arrival of his first, he always enjoyed taking his girls on adventures into NYC where they would explore the Bronx and Central Park Zoo, the aquarium, The Museum of Natural History, watch the Thanksgiving day parade, and one of their favorites, FAO Schwartz (where toy dogs may have been purchased and summarily walked down Fifth Avenue followed by Bill's raucous laughter.)

Not wanting to relocate his family to Texas to continue working for Kosta Boda, Bill moved on to the position of VP for COPCO for a short time before settling into Vice President in charge of Sales and Personnel for JPM. This position required Bill to leave the house at 5 a.m. to take a train and several buses (as his vision kept him from driving) to the factory in New Jersey. He loved to take his girls to work with him, though his youngest was afforded this opportunity the most. Those moments riding the train and bus (always with a stop for coffee and buttered roll first) are among her most cherished memories. He was loved and respected by everyone at JPM, but he loved to joke with the factory guys in the break room and they were always happy to sit and chat with him, as his stories were always the best.

His three girls were the center of his life, and his home in Lindenhurst was the center of his girls' activities. He prided himself in having an open door policy for all of their friends. Everyone felt welcome and enjoyed his kindness, and his culinary expertise. Everyone who knew Bill knew he enjoyed a good meal — many a story he told involved exquisite detail of the exotic meals he enjoyed while traveling the world. Once upon learning his wife had never had lobster,

Huntington Approves New 27,400 Square Foot Clubhouse at Indian Hills

The Huntington Town Planning Board approved a plan submitted by the Indian Hills Country Club to tear-down their existing 7,882 square foot clubhouse in Northport, and build a new 27,395 square foot clubhouse and catering hall. The Planning Board meeting was held on August 20th.

The project has been opposed by the local Fort Salonga Homeowners Association, due to concerns about increased traffic and noise from a much expanded facility.

The existing facility can host events of 150 people, however the new facility will be able to cater two weddings of over 200 people, at the same time,

according to attorneys for the Homeowners.

At the August 20th meeting of the Town of Huntington Planning Board, the Board unanimously approved the plan submitted by the Country Club and its architects, George Suddell Architects.

The Fort Salonga Home Owners Association sued to block the initial development plans, but the case was dismissed.

The site plan calls for 144 paved parking spaces, and an additional 84 spaces in the front of the building.

As part of the development plan, the Club is restricting its membership to 425 members.
